A WORD from CPL's Executive Director

Dear Friends,

I hope the New Year has brought you much joy and renewed optimism, as it has here at CPL. We are grateful for the many achievements in 2022, and look forward to meeting the goals for 2023. In the first month of this year, we have welcomed 8 snuggly, puppies into the CPL family.

In reflection of last year's accomplishments, we welcomed the return to in-person events, which were challenging during the pandemic. Our staff continues to welcome new and former volunteers back to campus, to support the mission. Last year, 12 new partnerships were formed, including 8 full service and 2 home companion teams, 1 courthouse companion and our first medical facility companion placement at Nemours Children's Health (read more about Talon at Nemours, in the following pages). We celebrated the opening of a new CPL Prison Puppy Raising Program at SCI Benner Township, bringing our total number of prisons to six. Some necessary improvements, including our kennel play yard expansion project, which added a new cement yard at the kennel and the installation of a drainage system to decrease the mud on the play yards. This project was completed just before our annual Fall Festival. We were able to raise over \$110,000, during our two fall giving day campaigns – a testament to your continued generosity and support of the CPL mission! I truly value each donation and every volunteer hour that you share with CPL. You enable the organization to change the lives of individuals in need of a service or companion dog and who want to live an independent life. Our mission brings people together, who share a love for helping individuals and their love for dogs. It takes many people to support the work and mission of this organization and I appreciate all you give. Thank you!

As a team, we could not be more excited for the year ahead. In January, we kicked off a rebranding project, which will include a new design of the CPL logo and a redesign of the website. CPL has grown tremendously since our inception more than 30 years ago and we now serve a much more diverse group of people. We want our brand and our logo to be respectful and inclusive of everyone we serve. We look forward to sharing our new logo and website in the coming months. The second phase of the Partnership

TALON

NEMOURS NEWEST STAFF MEMBER

Going to a medical facility can be stressful for people of all ages, but especially children. Some visits to the doctor's office are routine, but most kids are visiting when they are ill or due for vaccines. It's often an environment children are fearful of but the staff at Nemours in Wilmington, DE are working to change that.

Enter **Talon, a 3-year-old Lab/Golden mix.** Talon was placed at Nemours as a facility dog in September 2022. He is the first dog CPL has placed in a medical facility thanks to Dr. Byck, a Pediatrician at Nemours. Dr. Byck always thought

having a dog in the office would be beneficial for the children and after learning about CPL and starting the conversation, we were thrilled at the opportunity to expand our program to serve the medical community.

Talon spends his days visiting with patients to help ease their anxiety and make them feel more at home. He can often be found accompanying a patient to an exam room while they see their Pediatrician. He sometimes is brought into a room to help occupy siblings so a parent can focus on the Pediatrician and child being seen. Talon also loves to take walks with kids throughout the office. And, if you are lucky enough to have the last appointment of the day, you may just get to play ball with Talon once he takes his vest off and finishes "working" for the day.

but he has already made a huge impact. Children are more at ease during their appointments. Some kids who previously had a fear of dogs sit and pet Talon. There was even a child who was struggling with some behavioral issues and refused to talk to the Pediatrician yet he suddenly opened up and began speaking when Talon entered the room. In addition to working with patients on a daily basis, Talon has also done rounds in the hospital to visit with pediatric residents who are under a lot of stress. Dr. Byck said, "The biggest impact I wasn't expecting was the difference he makes in the staff. Everyone feels connected to him in some way. The volume of patients has been high this fall and winter and Talon has helped ease the stress and has brought fun and love into our office."

Talon has only been with Nemours for 4 months

Talon is meeting CPL's mission every day and thanks to him, he has turned a stressful experience into an enjoyable one for hundreds of kids in Delaware.



THE DOG HOUSE

You've seen fraternity and sorority houses lining the streets of college towns but have you ever seen a Dog House? 6 students from Lafayette College in Easton, PA live in a home, affectionately referred to as "The Dog House" and work together to raise puppies for Canine Partners for Life!

CPL and Lafayette College first partnered together in 2017. Lafayette has Living Learning Communities where faculty support student-to-student engagement in campus housing based on an academic curriculum. Currently, 6 students and 2 CPL dogs (Kramer and Wiss Fiss) live in The Dog House. The puppies accompany the students to classes, the library, the café and frequent the Quad to get some fresh air and greet fellow students. Every Sunday, the students meet to plan out the week ahead. They compare schedules to determine which student will take the dog to class each day, provide training sessions, playtime and more.

In addition to on-campus socialization, the dogs are frequent visitors of the restaurants in town and accompany the students to their hometowns on breaks. An advisor from the school, who is also a CPL volunteer, provides weekly training sessions for the students and dogs.

This partnership has been truly valuable for all involved.

It gives CPL the opportunity to raise additional puppies for our program and the puppies receive unique socialization opportunities throughout the college campus. The students involved dedicate countless hours to the puppies and gain critical skills they can carry with them after they

A TRIBUTE TO ESTHER

The world lost a bright light last April. Like a lot of us, Dr. Esther Ocuin had a passion and special connection to dogs, but Esther was also a compassionate advocate for people and supported both people and dogs in a multitude of ways during her life. Esther was an impressive woman. Born in Israel, she spoke 5 languages, was a veteran of the Israeli Defense Force, and served two tours in the United States Army where she earned the rank of Lieutenant Colonel. A physician by training, Esther was the first female interventional cardiologist at Walter Reed Army Medical Center at a time when women were uncommon, and sometimes unwelcome, in the field. She volunteered at a community clinic serving mostly-unemployed, extremely poor, medically complex uninsured patients of various ethnic minorities. She lived an accomplished life made full by her role as a daughter, wife and mother. When family and friends were asked to describe Esther, the words smart, grace, dignity and great sense of humor were frequently used.

In 2017, Esther was at the Kennedy Center in Washington, DC when a chance meeting with a CPL Graduate introduced her to the world of service dogs. Esther's husband, Dr. Jay Ocuin, said when Esther saw the team working she just had to speak to the person and learn more. From that moment she was hooked on the CPL mission, visiting campus, supporting programs and puppies in training. She was honored to be a part of the puppy naming program and was eager to see a dog she named graduate as a service or companion dog. While we lost her before she was able to see that happen, we are honored to carry on her spirit by naming one of our newest service puppies in training, Esther. Puppy Esther is described as very smart, curious, quick and eager to learn, and already devoted to her puppy raiser. Join us in remembering and celebrating Dr. Esther Ocuin and cheering on service dog in training, Esther!
